7. Bids shall be opened in presence of Bidders' representatives who choose to attend on 14:00 time and 11 July, 2019 at the office stated below. Bids must be valid for a period of **90 days** counting from the day of bid opening and must be accompanied by bid security, amounting to a minimum of NRS 4,50,000 which shall be valid for minimum 30 days beyond the bid validity period, 08 November, 2019.
8. If the last date of submission and opening falls on a government holiday then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
