- 5. The electronic bids must be submitted through PPMO's e-GP system **www.bolpatra.gov.np/egp** on or before **01:00PM on 08-Jan-2023**. Bids received after this deadline will be rejected.
- 6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 2:00 PM 08-Jan-2023 at the office of CDS and Clearing Limited, Putalisadak, Kathmandu. Bids must be valid for a period of 90 days from the date of bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs. 110,000 which shall be valid for 30 days beyond the validity period of the bid i.e. 08-May-2023
